Ethical Principles of Responsibility and Accountability. Responsibility is an ethical concept that refers to the fact that individuals and groups have morally based obligations and duties to others and to larger ethical and moral codes, standards and traditions. Responsibility in a business context refers to "a sphere of duty or obligation assigned to a person by the nature of that person's position, function or work."

As an agent or broker representing either the seller or the buyer, your primary duty is to "protect and promote" your client's interest, as defined by Article 3 of the Realtor Code.
