CBP Form 434, North American Free Trade Agreement (NAFTA) Certificate of Origin - also known as the CBP certificate of origin or the NAFTA CBP Form 434 - is a form used by the United States, Canada, and Mexico with the intention to certify that the goods qualify for the preferential tariff treatment agreed by NAFTA.

### **CBP Form 434 "North American Free Trade Agreement ...**

The CBP Form 434, Certificate of Origin may cover a single importation of goods or multiple importations of identical goods. Certificates that cover multiple shipments are called blanket certificates and may apply to goods imported within any twelve-month period specified on the Certificate.

The U.S. – Mexico – Canada Agreement (USMCA) does not require a specific certificate of origin form (CBP Form 434) as does the North American Free Trade Agreement (NAFTA). The CBP Form 434 is not mandatory under the USMCA. A claim for preferential treatment under the USMCA should contain nine minimum data elements.

### **UNITED STATES - MEXICO - CANADA AGREEMENT (USMCA ...**

This is a trilaterally agreed upon form used by Canada, Mexico, and the United States to certify that goods qualify for the preferential tariff treatment accorded by NAFTA. The Certificate of Origin must be completed by the exporter.

### **NAFTA Certificate of Origin | U.S. Customs and Border ...**

To avoid confusion, the CBP Form 434 will no longer be accepted for claims of preferential treatment under the USMCA. Even if the rule of origin for the subject good is the same under NAFTA and USMCA and all of USMCA's required data elements are present on Form 434, the good needs to be recertified under USMCA.

CBP Form 434, North American Free Trade Agreement Certificate of Origin, is used to certify that a good being exported either from the United States into Canada or Mexico or from Canada or Mexico into the United States qualifies as an originating good for purposes of preferential tariff treatment under NAFTA.

### **Agency Information Collection Activities: NAFTA ...**

CBP Form 434, NAFTA Certificate of Origin - This form is used to certify that a good being exported either from the U.S. into Canada or Mexico or from Canada or Mexico into the U.S. qualifies as an originating good for purposes of preferential tariff treatment under NAFTA. This form is completed by exporters and/or producers and furnished to CBP upon request.

### **NAFTA Certificate of Origin Under Review**

The renewal requires the Blanket NAFTA Certificate of Origin to be completed on the U.S. Customs and Border Protection (CBP) form 434 and be filed prior to the importation of the merchandise to receive the preferential duty treatment under NAFTA.
