Citizenship of Pakistan - Immigration to Pakistan

Entry into Pakistan is governed by the Passport Rules 1955. To enter into Pakistan a visa is generally required except in case of country which has reciprocal arrangements with Pakistan. All foreigners entering the country (not being Commonwealth citizens) must register with police within 24 hours. If they wish to stay in Pakistan after expiry of their visa, they must obtain permission of Police Department.

Immigration policy is overseen by the Interior Minister of Pakistan through the Directorate General Passports. Most immigrants are not eligible for citizenship or permanent residency , unless they are married to a Pakistani citizen or a Commonwealth citizen who has invested a minimum of PKR 5 million in the local economy.

One each should be handed over to Pakistan Immigration Officer on arrival and Police Registration Office. The applicant should be in possession of US \$45 or equivalent in Foreign Exchange at the time of entry. Pakistani law enforcement authorities will typically not notify the U.S. Embassy or Consulates if a foreign citizen is arrested or detained, unless you request they do so.
