A waiver or release of liability is a contractual clause designed to prevent a person who signed the contract from taking legal action and suing for personal injuries. Such waivers are often required as a condition of participating in an activity.

Most companies or business that allow participants to engage in sports or outdoor activities (such as white water kayaking, whitewater rafting, adventure races, skydiving, SCUBA diving, rock climbing, mountain climbing, snow skiing, snowboarding, water skiing, sailing, camping, hiking, triathlons, and surfing) usually have all of the participants sign liability waivers or releases of liability.
