If the system of European passporting of licences is discontinued without another appropriate arrangement in place, UK-based financial institutions will be classified as third-country financial institutions and will not be permitted to offer their services to clients in the EU without having obtained a licence from a supervisory authority within the EU for which they shall either establish a branch office or a full establishment.

The PRA and FCA together replaced the Financial Services Authority (FSA), the UK predecessor regulator, in 2013. The BoE's Financial Policy Committee (FPC) is responsible for macro-prudential regulation of the UK financial system and has powers to make recommendations to the regulators in certain circumstances.
